In respect of your college proposal for Renewal of Affiliation for A.Y. 2022-23 as per letter No.1, the Local Inspection Committee was appointed to submit its report with ref. letter no.2, for the college inspection.

Taking into consideration, as the Local Inspection Committee has visited your colleges & submitted the report. The Board of Deans have scrutinize/verified the information submitted by Local Inspection Committee.

The Board of Studies have given approval on behalf of Academic Council for Renewal of Affiliation/Natural Growth/ Students Admission and to the subject/courses for the period shown in the Table, vide clause 114(1) under Maharashtra Public University Act, 2016.

You are also informed that, this approval has been given to fulfill the necessary conditions as per NCTE norms and Standards 2014 .

In context of the above this approval has been given to your college for only one academic year, i.e. 2022-23, it is mandatory for the college to renew this affiliation time to time.

As per Maharashtra Public University Act 2016 Clause 108, it is mandatory to fulfill the conditions. So you are also informed that, you must comply the conditions laid by Local Inspection Committee within 03 months or before submitting the proposal of Continuation of affiliation for Academic Year 2023-24. If compliance report of the conditions laid by Local Inspection Committee not submitted by college then any proposals will not be accepted by the university for the Academic Year 2023-24. In this regard all responsibility will be of your college.

If the appointment of Principal, Librarian, Physical Director and 50 % Staff is not fulfilled by your college you must submit undertaking on Rs. 100/- Non-Judicial Stamp Paper. Only on that condition college is given Continuation of Affiliation and Natural Growth and Students Admission for the Academic Year 2022-23.

Table attached with this letter and mentioned in that, No Admission for First Year/ Direct Second Year such colleges are given only Continuation of Affiliation/Natural Growth. Such colleges should not given admission for the First Year and Direct Second Year. If the college submit compliance about appointment of Principal, Librarian, Physical Director, Staff and condition laid by Local Inspection Committee then about students admission would be considered.



If any matter is pending in the court about college subject to court order further process will be initiated.

NAAC/ NBA is obligatory for the college .

Hence, it is requested to take appropriate action in this regard.
